Upon call of the Chair, the Colbert County Commission met today in an emergency session at the Colbert County Courthouse in Courtroom Number Three. Chairman Black called the work session to order at 1:03 P.M. with the regular meeting following at 1:49 P.M., being the time and place previously scheduled for such work session, emergency, and regular meeting. All Commissioners answered "present" at the call of the roll. Chairman Black offered the invocation and led the Pledge of Allegiance. Chairman Black declared that a quorum was present for the purpose of the transaction of business.

CONSENT AGENDA

Chairman Black announced that the business before the Commission was the approval of the consent agenda. Commissioner Hovater made motion to adopt and approve the matters placed on the consent agenda during the work session. The motion was duly seconded by Commissioner Barnes. Chairman Black stated that the adoption and approval of a consent agenda comprised of the following items of business was properly before the Commission and stated the matters as follows:

The Commission finds that Tatum Oil is a company having a place of business within Colbert County, is a responsible bidder, and that the above-named products can be provided by Tatum Oil with no sacrifice or loss in quality of said products with respect to the products provided by other bidders. RESOLUTION NUMBER 2020-0026

A RESOLUTION TO CLOSE THE COLBERT COUNTY COURTHOUSE IN RESPONSETO THE COVID - 19 VIRUS.

WHEREAS the COVID-19 Virus is continuing to spread in the State of Alabama and the United States and has the potential of widespread exposure to an infectious agent that poses a significant risk of substantial harm to a large number of people; and

WHEREAS, the Governor of Alabama has declared that a state public health emergency exists in the State of Alabama; and

WHEREAS, the health and welfare of our citizens and the employees working in the Colbert County Courthouse are of great concern to the County Commission; and

WHEREAS, the Alabama Department of Public Health is promoting "social distancing" in hopes of slowing the spread of the virus; and

WHEREAS, the Colbert County Commission is committed to the continuation of essential operations during the period of declared emergency; and

WHEREAS, it is recognized that unprecedented measures may be necessary in protecting the public and slowing the spread of COVID-19.

NOW THEREFORE, BE IT RESOLVED THAT THE COLBERT COUNTY COMMISSION will close the Colbert County Courthouse to the general public from Wednesday March 18, 2020 until Monday, April 06, 2020.

BE IT FURTHER RESOLVED that employees who are deemed essential by the County Commission, by their department heads, or who otherwise are required to fill positions essential to maintaining County operations may be required to continue to work to provide necessary services on behalf of Colbert County, its employees, and its citizens.

BE IT FURTHER RESOLVED that each department head shall and is hereby authorized to determine which positions in his or her department are essential, and to designate his or her subordinate employees as essential.

BE IT FURTHER RESOLVED that as soon as practicable after the passage of this resolution, each department head shall meet with his or her subordinate employees and inform them of those positions or employees who are deemed to be essential to the maintenance of County operations and the dates and times during which such employees shall be required to report to work.

BE IT FURTHER RESOLVED that each department head be and hereby is authorized to do such things as he or she deems necessary or advisable in carrying out the directives of this Resolution during the period of Courthouse closure that he or she deems to be in the best interests of Colbert County, of his or her subordinate employees, and/or the citizens of Colbert County, Alabama.

BE IT FURTHER RESOLVED the Commission Chairman or incoming Chairman may approve, at the recommendation of the County Chief Financial Officer, the payment of necessary bills during the closure period.

RESOLUTION NUMBER 2020-0027

A RESOLUTION AND ORDER APPROVING CERTAIN AGREEMENTS BETWEEN THE COUNTY AND THE SOLID WASTE DISPOSAL AUTHORITY OF THE CITIES OF MUSCLE SHOALS, SHEFFIELD, AND TUSCUMBIA, ALABAMA

WHEREAS, the Solid Waste Disposal Authority of the Cities of Muscle Shoals, Sheffield, and Tuscumbia, Alabama (the "Authority") has proposed issue certain revenue bonds (the "Bonds") in order to finance the acquisition and improvement of the Cherokee Industrial Landfill (the "Project") located in the County; and

WHEREAS, the County will have no financial obligation with respect to such Bonds or any obligation of any kind with respect to the Project; and

WHEREAS, the County expects to be a customer of the Authority and to utilize the Project for public use; and

WHEREAS, the Authority has presented to the County a customer and flow control agreement and an agreement with respect to the payment to the County of a share of certain royalty payments from CWI Cherokee LF LLC to the Authority.

BE IT RESOLVED by the Colbert County commission (the "Commission"), the governing body of Colbert County (the "County"), as follows:

- 1. The Project proposed to be undertaken by the Authority is in the best public and financial interest of the County.
- 2. The TEFRA approval adopted by the Commission on March 3, 2020 is hereby further ratified and approved.

- 3. The Agreement between the Authority and the County for Municipal Solid Waste and Construction and Demolition Waste, Inert Waste, and Recyclable Materials is hereby ratified, adopted and approved, and the Chairman and County Administrator are hereby authorized and directed to execute, attest, seal, and deliver the same to the Authority.
- 4. The Intergovernmental Agreement between the County and the Authority with respect to the royalty payments is hereby ratified, adopted and approved, and the Chairman and County Administrator are hereby authorized and directed to execute, attest, seal, and deliver the same to the Authority.
- 5. The Chairman is authorized to execute and deliver on behalf of the County such other documents as may be reasonably requested by the Authority in connection herewith.
- 6. This resolution shall take effect immediately.
