Minutes of a Regular Meeting of the Colbert County Commission 06/21/2021

The Colbert County Commission met today in regular session at the Colbert County Courthouse. Chairperson Bailey called the work session to order at 5:00 p.m. All Commissioners were present for conduct of business at work session.

Prayer was conducted by Pastor Laura Thompson, Open Door Church. Commissioner Mansell led the Pledge of Allegiance.

PUBLIC COMMENTS

Mr. Russell Pigg, North Alabama Shoals Hospital, addressed the Commission on what he described as the community impact NAMC and Shoals Hospital have on the Lauderdale and Colbert Counties. He referenced the number of people employed, total payroll, taxes paid, services donated, capital investments, and stated that in 2020 a total economic impact in the amount of \$96,669,241.00 had been made. When asked, he clarified that only about a third of that economic impact benefitted Colbert County.

BOARD APPOINTEE REPORTS

Mr. Eddie Russell, NACOLG Non-Elected Board Member, reported to the Commission on NACOLG efforts to support Counties and Cities and referenced the "Nashville Big Backyard" initiative designed to increase tourism.

Chairperson Bailey presented the report submitted by Ms. Randa Hovater, Alabama Mountain Lakes Board Member. Lodging tax revenue was down 17.9%, 2020 as compared to 2019, but there appears to be a huge increase currently in travel. Mountain Lakes is sponsoring outreach efforts in the form of magazines and internet to increase tourism in the region.

PASSING OF THE GAVEL

Commissioner Bailey, outgoing Chair, passed the gavel Commissioner Bendall, incoming Chair, to serve for the next eight months in that position. Chairman Bendall gaveled the meeting to order at 6:47 p.m. All Commissioners answered "present" at the call of the roll. Chairman Bendall announced that a quorum was present for the purpose of transaction of business.

CONSENT AGENDA

Chairman Bendall announced that the business before the Commission was the approval of the consent agenda. Commissioner Gardiner made motion to adopt and approve the matters placed on the consent agenda during the work session. The motion was duly seconded by Commissioner Mansell. Chairman Bendall stated that the adoption and approval of a consent agenda comprised of the following items of business was properly before the Commission and stated the matters as follows:

1. Approved purchase of buildings and property from Muscle Shoals Holdings located off Reservation Road in Sheffield in the amount of \$750,000.00 to be paid from the County General Fund by adoption of the following Resolution:

RESOLUTION NUMBER 2021-0045

A RESOLUTION TO AUTHORIZE THE PURCHASE OF CERTAIN REAL PROPERTY FROM MUSCLE SHOALS HOLDINGS, LLC

WHEREAS, the Colbert County Commission is desirous of purchasing certain real property currently owned by Muscle Shoals Holdings, LLC, and being more particularly described as follows:

Tract X2NPT-33 a shown on plat recorded in Plat Book 2016, Cabinet C, page 195, as revised by plats recorded in Plat Book 2018, Cabinet D, page 7, and Plat Book, 2018, Cabinet D, page 4, all in the office of the Probate Judge of Colbert County, Alabama.

SUBJECT TO a permanent easement and right-of-way in favor of the United States of America, acting herein by and through its legal agent, the Tennessee Valley Authority, all over, upon, across, and under the approximately 135-foot wide strip along the southern boundary of Tract X2NPT-33 as shown on Exhibit B of that certain deed appearing of record at OFRD 2018, PG 20840 in the office of the Judge of Probate of Colbert County, Alabama, as "Public Road Right of Way" and the existing access road extending south from said Public Road Right of Way for the following purposes, namely, the perpetual right to enter at any time and from time to time and grade, level, fill, drain, pave, build, maintain, repair, rebuild, and use a road or highway, together with such bridges, culverts, ramps, and cuts as may be necessary.

FURTHER SUBJECT TO a permanent easement and right-of-way way in favor of the United States of America, acting herein by and through its legal agent, the Tennessee Valley Authority, all over, upon, across, and under the existing access road extending from Reservation Road across the portion of the Land identified as Tract X2NPT-33 to the parcel of land owned by the TVA Community Credit Union (TVA Tract No. XNPT-25), for the following purposes, namely, the perpetual right to enter at any time and from time to time and grade, level, fill, drain, pave, build, maintain, repair, rebuild, and use a road or highway, together with such bridges, culverts, ramps, and cuts as may be necessary.

WHEREAS the Colbert County Commission have reached an agreement as to the sales price of the above-described property and wish to enter into a purchase-sale agreement with Muscle Shoals Holdings, LLC regarding the same.

NOW THEREFORE, BE IT RESOLVED BY THE COLBERT COUNTY COMMISSION that Colbert County, Alabama, proceed with the purchase of the above-described property from Muscle Shoals Holdings, LLC, for the purchase price of \$750,000.00.

BE IT FURTHER RESOLVED that the County Attorney be and is hereby authorized to draft, with input from agents or representatives of Muscle Shoals Holdings, LLC, a formal purchase and sale contract setting forth the terms of said purchase.

BE IT FURTHER RESOLVED that, the Chairperson of the Colbert County Commission be and is hereby authorized to execute such purchase and sale contract on behalf of Colbert County, Alabama, and to execute such other documents as may be necessary, advisable, or convenient to complete closing of the purchase and sale contract on the terms stated therein.
