RESOLUTION NUMBER 2022-0043

A RESOLUTION TO VACATE A PORTION OF OLD COVERED BRIDGE ROAD

WHEREAS, Jamie Lynn Frick and Johna Betsy Frick are the owners of all of the lands and properties abutting the streets and rights of way hereinafter set out, being a part of West Old Covered Bridge Road; said Petitioners being desirous of vacating said street, or portions thereof, and having presented their signed Petition for Vacation to the Colbert County Commission, for its consideration, assent, and approval; and

WHEREAS, the property above referred to is more particularly described as follows:

PORTION OF RIGHT-OF-WAY TO BE VACATED:

That portion of a paved road known as Old Covered Bridge Road lying west of the Natchez Trace Parkway right-of-way. Said right-of-way being 25' on either side of the centerline of said roadway on the western right-of-way of the Natchez Trace Parkway and continuing thence in a westerly direction along the centerline of the existing pavement for approximately 900' to the end of pavement.

The above-described right-of-way being the same as that described in that certain prescriptive right of way declaration dated August 9, 2006, and appearing of record at Book 2006-30, Page 836, in the office of the Judge of Probate of Colbert County, Alabama.

WHEREAS, the aforesaid Petitioners, as the owners of all property abutting the said a portion of West Old Covered Bridge Road to be vacated, have complied with all requirements of applicable laws relating to the vacation of streets and rights-of-way within Colbert County, Alabama; and

WHEREAS, the Colbert County Commission has determined that convenient means of ingress and egress to and from their property is otherwise afforded to all other property owners owning property along the said West Old Covered Bridge Road, such means of ingress and egress being afforded by the remaining dedicated streets in the area.

NOW THEREFORE, BE IT RESOLVED BY THE COLBERT COUNTY COMMISSION, that the assent of the Colbert County Commission be and the same is hereby given and granted to the vacation of the portion of West Old Covered Bridge Road hereinabove described.

BE IT FURTHER RESOLVED that the Chairperson of the Colbert County Commission be, and said Chairperson hereby is, authorized and instructed to execute a quitclaim deed conveying to the Petitioners, in fee simple, that portion of West Old Covered Bridge Road hereinabove vacated to the extent it abuts the properties owned by the Petitioners, respectively.

Administrator Creekmore informed the Commission of the resignation of Roger Mitchell from the Colbert County Sheriff's Department.
