A RESOLUTION TO PARTICIPATE IN THE TENNESSEE RIVERLINE PILOT $COMMUNITY\ PROGRAM$

WHEREAS, Colbert County's location on the Tennessee River has played and continues to play and important role in the history, economy, and lifestyle of the residents of Colbert County; and

WHEREAS, the Tennessee RiverLine is a vision for a continuous system of multimodal trail experiences that provide users with continuous access to the 652-mile river and its 470,000-acre system of nine reservoirs, as well as national and state parks, wildlife refuges, TVA recreational land, and existing trails that line its banks; and,

WHEREAS, Colbert County believes that the Tennessee RiverLine is a worthwhile endeavor with great potential for improving the lives of residents and increasing tourist exposure to the history, culture, and natural beauty of the Tennessee River; and

WHEREAS, the Tennessee RiverLine is currently accepting applications for the Tennessee RiverLine Pilot Community Program in which the Colbert County Commission wishes to participate.

NOW THERFORE, the Colbert County Commission resolves as follows:

SECTION 1. Statement of Intent to Apply for Participation in the Program.

The Colbert County Commission hereby states its intent to complete the necessary application process for participation in the Tennessee RiverLine Pilot Community program.

The Colbert County Commission will support the tasks associated with being designated as a Tennessee RiverLine Pilot Community.

EMA Director Michael David reported that the 911 Autism Database Project has created an online data base for public to enter data and photos into. The heat advisory continues through the

He asked the Commission consider using the 4 large community storm shelters for cooling centers if needed. Chief Engineer Jeremy Robison reported that they may start moving dirt next week at the Leighton Ball field in hopes of it beginning to fix the standing water problems they are having there. He also thanked the Lawrence County Road Department for the loan of a road reclaimer. The yearly chip seal projects are progressing and will be completed soon.
