Chairman Bendall declared a quorum was present and the meeting was convened for the purpose of transaction of business. County Administrator Kathy Polk was also present and kept the minutes of the meeting. Commissioner Black offered the invocation.

PUBLIC COMMENTS

Chairman Bendall announced that a request for Mr. Todd Cooke to address the Commission would be the first order of business. Mr. Cooke addressed the Commission concerning the Colbert County Animal Control and the actions of the employees. Commissioner Barnes stated that he was the representative for the County Commission and will take this information to the next Animal Control meeting.

- 5. Approved request from Sheriff Williamson for 2004 Crown Victoria VIN#2FAHP71W54X178204 to be declared surplus.
- 6. Approved Tax Service Contract with Sales Tax Auditing & Collections Services (STACS) for continual of collection of Education tax and SIDC tax.
- 7. Approved resolution for Retirement System to make one lump sum payment to retirees for a total amount of \$44,174.00.
- 8. Approved request from Probate Judge Daniel Rosser for payment of \$1,931.15 for his services in certifying a voter's list to be used by the Absentee Clerk in the Special Primary Run-off Election on September 26, 2017.
