Minutes of a Regular Meeting of the Colbert County Commission 3/3/2020

The Colbert County commission met in regular session on Tuesday, March 3, 2020 at 5:00 PM, in the Commission Meeting Room of the Colbert County Courthouse, being the time and location appointed for such meeting to occur. Chairman Black called the work session to order at 5:00 PM with the regular meeting following at 6:23 PM. Commissioner Barnes was absent. All other commissioners answered "present" at the call of the roll. Commissioner Gardiner offered the invocation and led the Pledge of Allegiance. The Chair declared that a quorum was present for the purpose the transaction of business.
