The Colbert County Commission met today in regular session at the Colbert County Courthouse. Chairman Bendall called the work session to order at 5:08 p.m. with the regular meeting following at 5:28 p.m., the time and place previously scheduled for such work session and regular meeting. All Commissioners answered "present" at the call of the roll except for Commissioner Barnes who was absent. Commissioner Tyrus Mansell offered the prayer and led the Pledge of Allegiance. Chairman Bendall declared that a quorum was present for the purpose of the transaction of business.

Mr. Perry Burgess readdressed the Commission about reinstating COAARM's appropriation. Burgess asked for consideration of an appropriation of \$1,500 instead of \$2,500. Burgess made a special request to Commissioner Bailey to make the motion to reinstate the appropriation to COAARM with \$1,500 and thanked the Commission for listening and taking the appropriation request into consideration. He stated that they are still trying to keep their doors open and help our children. Commissioner Bailey responded that she has had some wonderful conversations with his wife and is still looking forward to going over COAARM's financials.
